- 1. Adopt Ordinance #15 of 2022 To Approve the Procedure to Sell Adjudicated Property. Motion by Brocato, second by Perry; motion passed.
- 2. Adopt Ordinance #16 of 2022 Amend Utilities Code, Chapter 38, Article 5. Rates and Charges Equipment Fee Schedule and Water Meter Rates; Motion by Perry; second by Jackson; motion passed.

#### New Business

- 1. Introduce Ordinance #1 of 2023- Amend Alcoholic Beverages, Article 1, Section 6-3. Drinking in public prohibited; to allow drinking of intoxicating liquors during the published hours of festivals and events sponsored by the town and only within the geographic boundary of the tract of land bordered by San Antonio Avenue, Smith Street, Ash Street and Main Street and the portions of those streets that border said tract of land. Motion by Brocato, second by Darwin; motion passed. Amended again to include to allow drinking along the parade route and for the duration of the parade and one hour before and one hour after the parade. Motion by Williams, second by Brocato; motion passes.
- 2. Amend Water Cut-Off Policy and Procedure Motion by Perry, second by Jackson; motion passed.
- 3. Enter into Intergovernmental Agreement with Sabine Parish Water District to supply them with water during emergency at a rate of \$35.00 for the month and \$4.25 per 1,000 gallons. Motion by Williams, second by Brocato; motion passes.
- 4. Enter into a Cooperative Endeavor Agreement with the Sabine Parish Police Jury to overlay Detention Center Road SPPJ will provide all equipment and labor to haul material and overlay Detention Center Road (approx. 2,200 feet) with asphalt Town of Many will pay for all material and cost associated with the asphalt overlay of Detention Center Road (approx. 2,200 feet). Motion by Brocato, second by Perry; motion passes.

- 11. Fire Board Report from Hable reporting the rating went from a 6 to a 5 to improved insurance rating; the parking lot at Central Station is being repaired for ADA compliance.
