Regular Council Meeting June 18, 2024

Public Hearing was held at 5:02 pm, June 18, 2024 prior to the Regular Council Session for the purpose of public comments on Ordinance #2 of 2024-Salary of Municipal Clerk at \$28.50 per hour and Ordinance #3 of 2024-Amend Utilities Code, Chapter 38, Article 5, Section 38-272 Rates and Charges-Equipment Fee Schedule and Water Meter Rates. No Comments. The hearing was closed with a motion by Brocato; seconded by Perry. Motion Passes.

- 8. Guests: Matthew McKee from Speaker Mike Johnson's office.

Departments-Town Operations Manager Jeremy Koss provided a report from the work order system, iWorQ.

- 1. Water: Installed a new service and flush valve behind City Hall; killed out the 4" main in the drive-thru at City Hall to repair leaking main; worked at the water plant tunneling under the concrete to replace a 1" water line; removed a 3" meter and installed a 6" meter in the vault box on Hwy 171 South; got Patrick Lane well site back online from tank work; kept the well sites and water office grounds looking good; built a cover over the control boxes at the Natchitoches well site where rain water kept getting in them; helped sewer dept. jet the main at Middlecreek Road; kept up with all work orders for the month.
- 2. Sewer: Been busy identifying more inflow and infiltration points in the collection system such as damaged manholes; mowing lift station sites; generator and lift station maintenance; maintaining wastewater plant. Corwin reports that CCR report is complete; we are good with DEQ now.
- 3. Street: Brush cutting and weedeating on Washington, Trace, Georgia, Alabama, Ponder, MLK, Highland, 171, Crest, Fisher Road, Dillon & Hill; finished culvert on 565 Trace; filling in potholes; mowed airport and ballpark; put up volleyball net at fairgrounds.
- 4. Animal Control: Picked up 11 cats and 4 dogs.
- 5. Airport: Fuel dispenser stopped working the last week of May; part for repair should be in this week; had a pre-bid meeting on June 13 for perimeter fencing; bid opening on June 25.
- 6. Grants: Suzanne provided a written report for 5/22/24 to 6/14/24.
- 7. Chief's Report: Written report for 5/20/24 to 6/17/24 proved by Chief Wooley; PD got a new server, made some major upgrades in technology the last couple of months; can now access Quick PD in police vehicles along with Thinkstream; completed the state's Click it or Ticket state program over two-week period surrounding Memorial Day; SRO grant was approved for renewal this month.
