Departments

- 1. Water-Koss provided iWorQ work order report for past month; fixed several leaks at meters and mains; off the chlorine cleanse now and going back to chloramines; keeping fence rows clean; installed a 3/4-inch tap at 200 Newton Road and two 1-inch meter taps for COA.
- 2. Sewer-jetted several main locations, knocking our plugs; jetting Smith Street in front of SPARK school every Wednesday; concreted over manhole rings in places; cleaned out contact chamber at the sewer plant; replaced several manhole lids.
- 3. Street-Finished mowing Rights-of-ways last week; keeping up with all "locates" for each department; replaced the culvert at intersection of Esso and E. Georgia St.; grass cut around fence at water plant.
- 4. Animal Control-12 cats and 1 dog was picked up for the Humane Society.
- 5. Airport-Myles Greer reported that the biggest project now is the perimeter fencing with FAA grant funds; we should be the bid offer in for construction in the next couple days; he was contacted by ULM as they are putting 50 mesonet weather stations around the state with no cost to towns, they want to do a site assessment at the airport next month.
- 6. Grants-written report supplied by Suzanne; also stated she has asked for a quote on theater aisle lighting as she and Brocato discussed; received a cost estimate from Meyer & Assoc. for Smith Street project to replace water main and sewer lines, add 2 fire hydrants, cut-off valves along with replacing the 12-inch main that keeps leaking, both projects would total up to \$350,000 so she is looking for grant opportunities; also she and Koss identified lake depth and property owners around Lanan Bay bridge for water intake relocation; had discussions with Kent at Schafer Plastics on cost for new 65 gallon roll out trash cans for garbage customers which would increase their garbage bill \$10/month for 5 months to over the cost; announced the Town received word of funding of a \$2 Million grant for sewer plant upgrades through LCDBG.
- 7. Chief's Report-Chief provided a written report for 7/16/24 through 8/19/24. Caden Clark has started POST academy this week; everyone else is already POST certified. The PD participated in Drive Sober or Get Pulled Over interdiction that began on August 16 and runs through midnight Sept 2.
