- 5. Approve Minutes: August 20, 2024 Regular Session on motion by Williams; second by Perry. Motion passed

- 7. Open for Public Comment relating to any item on agenda which requires council vote. None
- 8. Guests: Shannon Self with Shannon's Butcher Block-he is interest in leasing the Depot-would keep up with maintenance, mowing, repairs back to its historical state; interested in inside seating; cooking would be done in trailer; would also split electricity bill.

- 2. Adopt Ordinance #8 of 2024 Special Events-item tabled to wait and see what the SPPJ does.

### **New Business**

- 1. Resolution #16 of 2024 Authorizing the Mayor to Execute on Behalf and in the Name of the Town of Many a Contract for LCDBG Sewer Project Administrative Services with CDC on motion by Perry, second by Williams. Motion passed.
- 2. Resolution #17 of 2024 5 Year Capital Improvement Plan for Airport 2025-2029 on motion by Williams, second by Perry. Motion passed.
- 3. Discuss Tax Millage Change-Mayor explained that we are in a reassessment year and are required by the tax assessor's office to either roll forward to keep the 5.34 mills or change our resolution to 4.6 mills. Mayor said he will get a spreadsheet from the assessor's office to explain the difference; will have a special called meeting next week after obtaining more information.
- 4. Discuss future of Garbage Department-Hable reported that after having personnel issues for a while and having to use employees from other department plus truck repairs on both trucks with the warranties out on both of them, we had thought about contracting trash pick up out, but now we have 2 good employees on the back of the truck plus a back-up and things are going well. Only thing we need to look at now is increasing rates because we have not increased them since we started with our own trucks and are now in a deficit providing this service.
- 5. Discuss Garbage Bins for Residents-Mayor said he would like to move forward with this. Williams said it would make our town look so much better. Mayor said he would like to wait on Suzanne and Mary B & Anita to be here to make the decision.
- 6. Discuss Price Increase on Bulk Water-Mayor said it was brought to his attention that we are losing business to local systems based on our current rate of \$ 65 per 1000 gallons plus \$25 set up fee. Koss suggested going to \$15-\$20 per 1000 gallons or charge what we charge our customers. Hable said we can vote at the special called meeting next week or at the regular meeting next month.
- 7. Update on Survey of City Limits-Map and picture of survey markers provided from surveyor.
- 8. Issue permit for Sabine Parish Fair and Rodeo Parade for Saturday, September 28th, Lineup at 12:00 p.m. at St. John's Catholic Church, Parade will start at 1:00 p.m. Motion by Williams; second by Perry. Motion passed.

9. Chief's Recommendation to hire Auston Bliss as a full-time officer at \$15.00/hour with a starting date of 9/11/2024. Motion by Williams, second by Perry. Motion passed.
