5. Approve Minutes: November 18, 2025 – Regular on motion by McLendon, seconded by Brocato; motion passed.
6. Amend Agenda to Adopt Resolution #24 of 2025 for MWPPP for the monitoring period of 2024; motion to add by Brocato, seconded by McLendon; motion passes.

**Departments**- Koss handed out iWorQ reports for November

1. Water: Meter install on Texas Hwy at Shady Oaks; repaired leaks at Hawthorne & Church Streets, 2 on Capitol Street, 2 on N. Robinson; repaired 6" main by new donut shop twice (Hwy 171 & West Alabama); stayed current on work orders.
2. Sewer: Jetted blockage by RR tracks in the woods for 3 days; cleaned manhole on Henry St; jetted sewer mains at Ritter & Trace and on West Georgia; jetted and camera sewer at 5-way intersection; stayed current on work orders and locates. Corwin said we can close out the compliance order for sewer plant now that we are going to be doing upgrades at the facility.
3. Street: Worked Christmas parade and fireworks; fixed driveway on BW Lane; started work on Leon James Park by cleaning it up; burned piles of green waste; started sidewalk repair at Taylor House; used MowerMax on MLK Drive; cleaned up Ivanhoe & Mississippi street; got storage building moved from airport to barn with concrete approach poured (will be used for Christmas decorations); poured new driveway at 610 Lawrence Street.
4. Animal Control: Picked up 6 cats & 4 dogs for the animal shelter
5. Airport: No report
6. Grants: Suzanne reported she has submitted a grant for bulletproof vests, submitted a water sector grant application to replace water and sewer lines on Smith Street with road repairs, and the Capital Outlay grant request has also been submitted. She will leave a written copy of her report in the councilmember's mailboxes in the office.
7. Chief's Report: Chief provided a report for November 2025 but highlighted period of 1/1/25-12/14/25 with 1430 stops, 1218 citations given, 147 arrests with 46 felonies.

Motion to adopt by Brocato, seconded by McLendon; motion passed.
2. Adopt Resolution #22 of 2025 – Authorizing the Mayor to Complete, Sign, and Submit an Application for a Grant of Funds from the Local Government Assistance Program (LGAP) in the Amount of \$35,000; To Sign Requests for Payments (RFP); and for Grant Writer to Certify Signatures on all Necessary Forms. Motion to adopt by Brocato, seconded by Darwin; motion passed.
3. Adopt Resolution #23 of 2025 – Giving Preliminary Approval to the Issuance of not Exceeding \$570,000 Taxable Excess Revenue Bond of the Town of Many for the Purpose of Paying Costs of Constructing and Acquiring Improvements, Extensions and Replacements to the System, Including Equipment, Fixtures and Accessories therefor, a Work of Public Improvement for the Issuer, and Paying Costs of Issuance. Motion to adopt by Darwin, seconded by Brocato; motion passed.
4. Approve Amendment No. 1 to the Mowing Agreement with DOTD to add an Additional \$12,500 Per Year for Cutting the State Right-Of-Ways - Motion to approve by Brocato, seconded by McLendon; motion passed.
5. Vote to Amend the Current Annual Budget for the Reasons Outlined on the Budget Spreadsheet - Motion to approve by Darwin, seconded by Isgitt; motion passed.
6. Appoint a representative to serve on the Sales & Use Tax Commission Board – Lane Isgitt appointed on motion by Brocato, seconded by Darwin; motion passed.
7. Adopt Resolution #24 of 2025 for MWPPP (Municipal Water Pollution Prevention Program) for the monitoring period of 2024 – Motion to adopt by McLendon, seconded by Darwin; motion passed.
