Special Called Session

The Mayor and Aldermen of the Town of Many met in special session, Wednesday, June 15, 2017 at 12:00 pm. at Town Hall. Present were Mayor Freeman and Council Members Gay Corley, Bobbie Jackson, James Kennedy, and Mayor Pro Tem Barbara Peterson. Absent was Anita Darwin. Also present was Deputy Clerk Ashley Garcie, and Water Supervisor Charlie Brown

The purpose of the meeting:

1. Review and Award Bid: Asphalt

1. **Review and award bid for Asphalt** – A motion to approve the asphalt bid for Lites Brothers Asphalt for FY 2017-2018, was made by Gay Corley and seconded by Barbara Peterson. Vote unanimous.
2. **Review and Award Bid for Chemical:** There was a motion made to approve the bid for 150# Cylinder of Liquid Chlorine for \$120.00 each and 2000 # Container of Liquid Chlorine for \$1250.00 each by Gay Corley and seconded by Bobbie Jackson. There was a motion to accept Harcros Chemicals for the purchase of Soda Ash by Barbara Peterson and seconded by Gay Corley. Vote unanimous. There was no bid received for the Alum Sulfate and the Mayor instructed Charlie Brown to get three bids before we purchase the chemical.
3. **Review and Award Bid – Fiscal Agent:** There was a motion by Gay Corley and seconded by Bobbie Jackson to accept Bank of Montgomery as our Fiscal Agent for 2017-2021.
4. **Award Administrative contract to GNF Management for LCDBG:** There was a motion by Gay Corley and seconded by Barbara Peterson. Vote unanimous.
5. **Award Engineering Contract to KSA Engineers for the LCDBG grant-** There was a motion made to accept KSA as our engineers for the LCDBG grant by Gay Corley and seconded by Bobbie Jackson. Vote unanimous.
6. **Approval to open bank account for Street – Equipment Savings:** There was a motion to open the street bank account by James Kennedy and seconded by Barbara Peterson. Vote unanimous.
7. **Discontinue Lockbox Services:** There was a motion made by Gay Corley and seconded by Barbara Peterson. Vote unanimous.
