

RESOLUTION #12 OF 2022

A RESOLUTION TO ENTER INTO A COOPERATIVE ENDEAVOR AGREEMENT WITH THE SABINE PARISH POLICE JURY

BE IT RESOLVED that the Aldermen of the Town of Many do, hereby, authorize Mayor Robert H. Hable, Jr. to enter into a cooperative endeavor agreement between the Town of Many and the Sabine Parish Police Jury ("Police Jury") in which the Town of Many will donate the reclaimed asphalt pavement (RAP) that it owns and has stored at the Many Airport to the Sabine Parish Police Jury;

WHEREAS, Article VII Section 14(C) of the Constitution of the State of Louisiana of 1974 provides, "For a public purpose, the State and its political subdivisions or political corporations may engage in cooperative endeavors with each other, with the United States or its agencies, or with any public or private association, corporation, or individual"; and

WHEREAS, the Town of Many and the Sabine Parish Police Jury have the authority to enter into this Agreement as evidenced by their governmental purpose of repairing roads when such work will further the best interests of the citizens of the town and parish; and

WHEREAS, the public purpose of the project is described as: to provide safe roadways for travel by the citizens of Sabine Parish; and

WHEREAS, the Town of Many and Sabine Parish Police Jury have a reasonable expectation of receiving a benefit or value described in detail that is at least equivalent to or greater than the consideration described in this Agreement; and

WHEREAS, the expenditure of public funds is not a gratuitous donation;

WHEREAS, the Sabine Parish Police Jury will use the RAP received from the Town of Many to produce oil sand material, the Police Jury will load the RAP at the airport, transport the RAP to

the processing site (pug mill), provide road oil and sand for processing the RAP, and provide the contract labor for processing it into oil sand; and

WHEREAS, the Police Jury will haul 25% (expected to be approximately 500 tons) of processed oil sand from the processing site back to the Botan Road location; and

WHEREAS, notwithstanding any law to the contrary, and LSA-R.S. 48:91 in particular, it is agreed there is no intent that such repairs by the Sabine Parish Police Jury should and shall not affect the designation of Botan Road as a municipal street of the Town of Many; and

WHEREAS, all remaining oil sand (75%) will become the property of the Sabine Parish Police Jury for use at its sole discretion.

THUS DONE the 16th day of August, 2022 at a regular session town meeting of the Mayor and Board of Aldermen.

THUS ADOPTED on motion by Brocato, seconded by Williams and unanimously approved.
