

## ORDINANCE #6 OF 2023

### AN ORDINANCE ADOPTING THE ANNUAL BUDGET OF REVENUE AND EXPENDITURES FOR THE FISCAL YEAR JULY 1, 2023 TO JUNE 30, 2024, TOWN OF MANY

**THEREFORE BE IT ORDAINED** by the Board of Aldermen of the Town of Many, Louisiana in legal session convened that the above Ordinance having been duly introduced at a special called meeting of the Aldermen on the 28th day of June, 2023 was put to a vote with a motion by Darwin and seconded by Perry and recorded as follows.

SECTION 1: The attached estimate of revenues as reflected in the consolidated statement, and such other fiscal exhibits and information as required by Section 1308 [D], Louisiana Local Government Budget Act, be and the same is hereby adopted to serve as the budget of expenditures for the Town for fiscal year July 1, 2023 to June 30, 2024.

SECTION 2: The attached estimate of revenues as reflected in the consolidated statement, and such other fiscal exhibits and information as required by Section 1308 [D], Louisiana Local Government Budget Act, be and the same is hereby adopted to serve as the budget of expenditures.

SECTION 3: The adoption of the budget of expenditures as reflected in the attached budget containing object of expenditure classifications shall be declared to be the appropriation of the amounts set therein as established in each budget classification by object of expenditure. All salaries are hereby adopted by this section.

SECTION 4: The amounts appropriated for all accounts shall not exceed the amount fixed therefore in the budget of expenditures. Nothing contained in this authority from amending or making an appropriation to and for a contingent fund to be used in cases of emergency.

Any ordinances or parts of ordinances in conflict with this ordinance, to the extent of that conflict, are hereby repealed.

The above Ordinance having been duly introduced at a special called meeting of the Aldermen on the 28th day of June, 2023 and duly advertised in accordance with law, and a public hearing has on same, was put to a vote with a motion by Alderwoman Darwin and seconded by Alderwoman Perry and recorded as follows.
