ORDINANCE #8 OF 2023

AN ORDINANCE ANNEXING 101 ZACHARY TAYLOR ROAD INTO THE CORPORATE LIMITS OF THE TOWN OF MANY

THEREFORE, BE IT ORDAINED by the Board of Aldermen of the Town of Many, Louisiana in legal session convened that the above Ordinance having been duly introduced at a regular meeting of the Aldermen on the 22nd day of August, 2023 was put to a vote with a motion by Brocato and seconded by Perry:

WHEREAS, a petition has been filed in accordance with Revised Statues R.S. 33:172, the following described property, to-wit:

Parcel #0040142860

A 1.621 AC TRACT LOCATED IN THE NE/4 OF SECTION 13-07-11

WHEREAS, the petitioners (Chris L. & Susan W. Abrahams) are the sole owners of the entirety of the above described property; and

WHEREAS FURTHER, Mr. Chris Abrahams is the only person living within the area to be annexed and is a registered voter within the area to be annexed, all of which is evidenced by a certificate from the Parish of Sabine, Assessor's Office, which was filed with the petition for annexation; and

WHEREAS FURTHER, the matter has been considered by the Town Aldermen; and

WHEREAS FURTHER, an opportunity has been given to all interested persons in accordance with Louisiana R.S. 33:172, et seq.; and

WHEREAS FURTHER, a public hearing has been called for the consideration of the annexation ordinance on September 19, 2023.

NOW THEREFORE, BE IT ORDAINED by the Aldermen of the Town of Many, in legal session assembled, as follows:

Section I.

The boundaries of the Town of Many are hereby enlarged so as to include the above described property, to-wit:

Section II.

BE IT FURTHER ORDAINED that this Ordinance shall go into effect and shall become operative thirty (30) days after it has been published once in the Sabine Index, the official legal journal of the Town of Many, all in accordance with Louisiana R.S. 33:173.

Section III.

BE IT FURTHER ORDAINED that the Town of Many takes cognizance of the fact that this Ordinance was introduced at a special session of the Aldermen on the 22nd day of August, 2023, after receiving a petition.

Section IV.

BE IT FURTHER ORDAINED by the Aldermen that the above and foregoing property be, and it is hereby annexed to the Town of Many, and is declared to be included in Aldermen District B.

BE IT FURTHER ORDAINED by the Aldermen that this Ordinance shall be in effect thirty (30) days after publication of this Ordinance, in accordance with Louisiana R.S. 33:173.

The above Ordinance having been duly introduced at a regular meeting of the Aldermen on the 22nd day of August, 2023, in accordance with law, was put to a vote by the Mayor, and the vote was recorded as follows:
