## RESOLUTION #1 OF 2020 to Adopt R.S. 39:1645 for the Purchase of Used Equipment<sup>1</sup> Used Garbage Truck

Whereas the Town of Many follows the Public Bid Law for the purchase of moveable equipment—Title 38, Section 2212.1 of the Louisiana Revised Statutes; and

Whereas Title 38 makes no provision for the purchase of used equipment exceeding the cost of \$10,000 without following the advertisement and bid processes provided in the Public Bid Law; and

Whereas R.S. 39:1554(E)(1) authorizes political subdivisions to adopt any part of Title 39 and accompanying regulations regarding purchases; and

Whereas R.S. 39:1600(C) provides an alternative method to purchase used equipment without the necessity of a public bid if the purchase of used equipment is cost effective; and

Whereas, the Town of Many has immediate need of a Used Garbage Truck and placing a bid for a Used Garbage Truck impracticable;

Now Therefore, let it be resolved by the Board that:

- 1. The **Town of Many** will adopt and utilize Louisiana Revised Statute Title 39, Section 1600(C), for the purchase of a **Used Garbage Truck** as it has been determined that the purchase of the vehicle used is more cost effective than the purchase of new equipment.
- 2. The head of the department which will use the equipment, or the procurement staff assigned to purchase the equipment, shall certify in writing to the board the following as required by Rule-Title 34 Section 901B of the Louisiana Administrative Code:
  - a. the price for which the used equipment may be obtained; and
  - b. the plan for maintenance and repair of the equipment and the cost thereof; and
  - c. the savings that will accrue to the town because of the purchase of the used equipment;
  - d. the fact that following the formal bid procedures set out in the Public Bid Law will result in the loss of the opportunity to purchase the equipment.
- 3. Where such a certification is made, and upon approval by the board, the purchase may be made of a **Used Garbage Truck** for an amount not to exceed \$85,000.00.
- 4. This resolution shall remain in effect until the desired piece of equipment is delivered.

<sup>1</sup> Local governmental and political subdivisions are required to follow the Public Bid Law for the procurement of materials and supplies and public works projects. They may, however, use the LPC for the procurement of materials and supplies when best interest dictates. They may choose by ordinance or resolution to adopt the LPC in part or in its entirety.
